# THE UNREDACT CHALLENGE – LEGAL RULES

## ELIGIBILITY

The [Unredact Challenge Sweepstakes](#) is open to legal residents of the United States only. Entrants must be 18 years of age or older as of their date of entry in this promotion to qualify. This sweepstakes is subject to federal, state, and local laws and regulations and void where prohibited by law. Bishop Fox's employees, its subsidiaries, affiliates, suppliers, partners, advertising and promotion agencies, and directors (collectively the "Employees"), as well as members of an Employees' immediate family and/or those living in the same household of Employees are ineligible to participate in the Unredact Challenge Sweepstakes.

## **PRIZES**

The Winner(s) of The Unredact Challenge Sweepstakes (the "Winner") will receive:
